

2. They should likewise request all the identified participants to be present during the activity. However, care and utmost discretion should be employed on deciding on the schedule of the activity so that no class will be disrupted as DepEd works on its Learning Recovery Plan.
4. All expenses relative to the conduct of this activity shall be charged to their respective MOOE/SEF/Local Fund subject to the usual accounting and auditing rules and regulations.

The undersigned would like to express deep gratitude to your positive response to our letter dated 11 May 2023 regarding our proposal to conduct information and awareness campaigns in DepEd-8-supervised schools with your issuance of DepEd-8 Regional Memorandum No. 551, s. 2023 dated 05 June 2023 Re: Regional Task Force to End the Local Communist Armed Conflict (RTF8-ELCAC) Situational Awareness and Knowledge Management (SAKM).

We further request the assistance of your school heads for us to engage the learners' parents, through the Parents and Teachers Associations (PTAs), present to them these orientations and call for their active support and participation in the
