ROLLOUT OF FOUNDATIONAL COURSE ON ADOLESCENT HEALTH CARE FOR SECONDARY SCHOOL IMPLEMENTERS

- 1. In support of DepEd's commitment under R.A. 10354 or the Responsible Parenthood and Reproductive Health Act of 2012, which mandates the institution to deliver a sustainable and age- and development-appropriate reproductive health education and training for educators to create an inclusive and integrated Responsible Parenthood and Reproductive Health Education, this Schools Division, through the SGOD School Health Section and the Human Resource Development Section Gender and Development, will conduct a three-day live-out Rollout of Foundational Course on Adolescent Health for Secondary School Implementers on March 22-24, 2024 at a venue to be announced in a subsequent memorandum.
- 2. This activity aims to capacitate teachers from all secondary schools with indepth knowledge to better understand the development of adolescents, enabling them to be adept in providing the right services to adolescents. Thereby, ensuring that they can provide comprehensive Adolescent Reproductive Health (ARH) education to learners aligned with DepEd.
- 3. The target participants of this training shall be (1) School Head/Gender and Development (GAD) Coordinators and (1) Guidance Counsellors/Designate in all Secondary Schools. Moreover, identified participants are expected to comply with the following:

Expenses relative to the conduct of the activity such as meals, training kits, venue rental, board and lodging, and travel and other incidental expenses incurred by School-based participants shall be charged against their local fund/MOOE/GAD Fund subject to the usual accounting and auditing rules and regulations.
