POLICY ORIENTATION ON THE DEPED ORDER NO. 05, S. 2024, RATIONALIZATION OF TEACHERS' WORKLOAD IN PUBLIC SCHOOLS

AND PAYMENT OF TEACHING OVERLOAD

- 1. The Department of Education (DepEd) issued DepEd Order No. 5, s. 2024 or the Rationalization of Teachers' Workload in Public Schools and Payment of Teaching Overload. This policy aims to cultivate a more conducive work environment by streamlining the teachers' day-to-day tasks, setting their official working hours, and providing guidelines for the payment of teaching overload.
- Anent to this, DepEd Division of Northern Samar through the Office of the Assistant Schools Division Superintendent shall conduct a policy orientation on the above mentioned DepEd Order on July 12, 2024, at the venue to be announced later.
- 3. This activity aims to discuss and provide direction on the policy's salient features, including the duties and responsibilities of the field offices, and to clarify common concerns and come up with one common understanding of the DepEd Order.
- 4. Participants in this activity are ALL School Heads (Principals, Head Teachers, TICs) of both Elementary, Junior High School, and Senior High School and the selected key personnel of the Schools Division Office. This MEMO shall serve as a TRAVEL ORDER of the participants.
- 5. Meals and other incidental expenses related to this activity shall be charged against Division MOOE while the travel expenses to be incurred by the School Heads shall be charged from their school MOOE subject to the usual accounting rules and regulations.
- Immediate dissemination of and compliance with this Memorandum are highly desired.
