- 4. The District SELG and SSLG Presidents shall be the participants for the Division Level Learner Government Elections, they shall be accompanied by their respective advisers.
- 5. The advisers shall submit to the secretariat the **Certification** provided by the District Heads as proof that the SELG and SSLG Presidents are the official representative of their District SELG and SSLG.
- 6. The venue for the Division Level Learner Government Elections shall be at the Division Office's **Bulwagan ng mga Guro**, the participants are expected to be in the venue at exactly **8:00 in the morning** of the said date.
- 7. The outgoing DFSSLG Officers are advised to attend the activity to assist in the election process, however the outgoing DFSSLG Officers who shall represent their respective districts and the same shall run for an elective position shall not be required to assist in the election process.
- 8. The DRRM Forum shall be held after the Division Federated Learner Government Elections which shall be facilitated by the Division DRRM Focal.
- 9. The issuance of this Memorandum shall serve as Travel Authority for those concerned. All expenses incurred in the conduct of this activity shall be charged to the local funds/MOOE subject to usual accounting and auditing rules and regulations.
- 10. Attached to this Memorandum is the Consent, Waiver, Indemnity and Release Form consolidated in one document. The District SELG and SSLG Presidents shall fill-out this form with the approval of their parents which the latter shall also sign the form. This shall be submitted to the Division Youth Formation Coordinator or the Learner Rights and Protection Focal on the same date, before the election proper.
