- Pursuant to Regional Memorandum No. 842, s. 2024 titled, Regional Upskilling of English Teachers in Language Instruction, this Office, through the Curriculum Implementation Division, announces the conduct of the Division Upskilling of Key Stage 2 English Teachers in Language Instruction on March 10-13, 2025 at Ciriaco Hotel and Resort, Calbayog City.
- 2. The objectives of the activity are the following:
 - a. conduct a division rollout of the regional upskilling of English teachers;
 - b. facilitate the high-quality professional learning opportunities for English teachers; And,
 - c. devise teaching strategies and techniques that develop learner's communicative language competence.

- 5. The cost of meals, snacks and accommodation shall be charged to the 2023 Continuing Fund; whereas, travelling expenses of the participants to school/local MOOE subject to the usual accounting and auditing rules and regulations.
