UPDATES ON THE CONDUCT OF THE DIVISION-BASED SCREENING AND CERTIFICATION OF NEAP ROS AND SDO POOL OF LEARNING FACILITATORS

- 1. In reference to Division Memorandum No. 80, s. 2025, this Office, through the Schools Governance and Operations Division Human Resource Development Section, hereby informs all National Educators Academy of the Philippines (NEAP) RO8 and SDO Pool of Learning Facilitators about the screening and certification activity scheduled for March 17-19, 2024, at the Bulwagan ng mga Guro and Library Hub Conference Room, Schools Division Office.
- 2. This activity aims to screen and certify learning facilitators who will compose the vetted faculty and participate in the National Training of Trainers (NTOT) for the Phase 2 implementation of the Revised K to 12 Curriculum G2358.
- 3. The **NEAP RO8 Pool of Learning Facilitators** will automatically become members of the vetted faculty and participate in the NTOT. For the certification process, **NEAP RO8 LFs** who have facilitated any NEAP-accredited Professional Development (PD) programs (e.g., ILT, HOTS-PLPs, MATATAG, etc.) or PD programs implemented by the Curriculum and Learning Management Division (CLMD) of DepEd Region VIII must submit the MOVs specified in DM No. 80, s. 2025 on **March 17, 2025, until 12:00 NN** at the HRD office. Conversely, those without learning facilitation of any of the abovementioned PD programs will undergo certification by NEAP RO8 upon completion of the NTOT.
- 4. Meanwhile, the **SDO Pool of Learning Facilitators**, those who have responded in the Google Sheet and have master's degree in accordance with the minimum requirements set by NEAP, shall undergo Phases 2 and 3 of the screening





process-Facilitation Skills Demonstration and Behavioral Events Interview-on March 18, 2025 (see enclosed List of Learning Facilitators for Screening).

- Learning Facilitators will be divided into three (3) groups and shall proceed to the following designated screening and certification venues: Bulwagan A, Bulwagan B, and Library Hub Conference Room.
- 6. Expenses incurred relative to the conduct of this activity, such as meals of the program management team/technical working group, shall be charged against the 2024 Division MOOE (SGOD GASS), while travel and other incidental expenses of the participants shall be charged against their local funds/MOOE, subject to the usual accounting and auditing rules and regulations.
- 7. This Memorandum serves as the **Authority to Travel** of the participants.
- 8. Immediate dissemination of and strict compliance with this Memorandum are desired.
