- 1. In support of the Provincial Government of Northern Samar's ongoing rehabilitation and reintegration initiatives for Persons Deprived of Liberty (PDLs) at the Northern Samar Provincial Jail (NSPJ) —and reaffirming DepEd Northern Samar's full commitment to this collaborative endeavor—a two-day live-out Resource Package Development for the Character Transformation Program for PDLs will be conducted on April 29-30, 2025, at the Provincial Planning and Development Office (PPDO) Conference Area, 2F, Provincial Capitol, Brgy. Dalakit, Catarman, Northern Samar.
- 2. This activity aims to initiate the writing process for the proposed *Character Transformation Resource Package*, which will serve as a guide for facilitators of the 52-week sessions. It will provide direction on content development and delivery methodologies to ensure full alignment with the rehabilitation and reintegration goals for Persons Deprived of Liberty (PDLs). This initiative falls under the Education Pillar for the ongoing enhancement of the Northern Samar Provincial Jail, led by its OIC-Provincial Warden, EnP Jay Keenson C. Acebuche.
- 3. Representatives from the Roman Catholic Diocese of Catarman, the University of Eastern Philippines, and other private and key partner agencies will actively participate in the workshop—bringing their expertise and insights as they review and critique the Resource Package's comprehensiveness, contextual relevance, and practical effectiveness for PDL rehabilitation.
- 4. Recognizing the pivotal role of education in fostering transformation and rehabilitation, the following DepEd personnel are invited to participate in the workshop. In response also to the public call for volunteers issued by the Provincial







Government, the following teaching and non-teaching personnel have likewise signified their intent to participate (See attached list).
