**SCHOOL HEALTH SECTION MID-YEAR PROGRAM IMPLEMENTATION REVIEW FOR  
SCHOOL-BASED FEEDING PROGRAM AND OTHER OPLAN KALUSUGAN (OK) SA  
DEPED PROGRAMS AND PLANNING CONFERENCE FOR SY 2025-2026**

To: Assistant Schools Division Superintendent

All School Health & Nutrition Section Personnel

1. To assess the implementation status of the School-Based Feeding Program (SBFP) and other Oplan Kalusugan (OK) sa DepEd Programs, and to ensure the effective planning and delivery of health and nutrition services for School Year (SY) 2025-2026, the Schools Division Office, through the School Health Section, will conduct a Mid-Year Program Implementation Review and Planning Conference on May 8 & 9, 2025. The final venue of the activity shall be announced through a separate advisory once confirmed.
2. The activity aims to:
  - a. review the mid-year implementation status of the School-Based Feeding Program (SBFP) and other Oplan Kalusugan (OK) sa DepEd Programs;
  - b. identify challenges, gaps, and best practices in program implementation;
  - c. provide technical updates on recent policies and guidelines;
  - d. formulate strategic plans for School Year 2025-2026, including health initiatives for Brigada Eskwela 2025; and
  - e. strengthen coordination among School Health Section personnel for improved program delivery.
3. All School Health Section personnel, including those assigned to autonomous schools or under school-based plantilla, are required to attend this activity.
4. All expenses relative to the conduct of this activity such as meals, venue, accommodation, travel and incidental expenses of the participants, facilitators, program management team shall be charged against **School-Based Feeding Program (SBFP) Program Support Fund (PSF)**, subject to the usual accounting and auditing rules and procedures.
5. This Memorandum shall serve as **Official Travel Authority**.
6. Immediate dissemination of and compliance with this Memorandum are desired.
