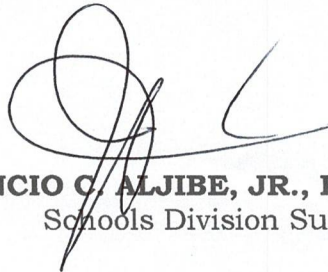

 - f. Utilize data gathered to inform Regional TA providers of assistance needed and for policy formulation.
3. Expenses that shall be incurred in the conduct of TA-related activities, to include travel expenses, shall be charged against local funds/MOOE subject to the usual accounting and auditing rules and regulations.
