1. In celebration of the 60<sup>th</sup> Founding Anniversary of the Province of Northern Samar, the Provincial Youth Development Office in partnership with the SGOD- Youth Formation Division will hold the **Ibabao Youth Summit** from **June 9-11, 2025 at Generoso R. Frigillana Memorial School in Barangay Dalakit, Catarman Northern Samar**, with the theme **"Ibabao Forward: YOUTH Lead Towards a Sustainable Future"**.
2. The event aims to bridge the gap among the youth from the 24 municipalities in the province and provide a platform for connection, collaboration, and capacity building. By gathering the youth from diverse sectors to foster an environment for relationship-building, knowledge exchange, and the development of a shared vision for the province's future.
3. There will be a total of 200 participants consisting of the Sangguniang Kabataan, youth organization and the 46 District Supreme Secondary Learner Government (SSLG) Presidents. They will be divided into four groups/camps (**see attached enclosure 1**).
4. With this, SSLG advisers of the District SSLG Presidents are advised to inform the latter of this undertaking but they shall not act as their chaperon since, there will be only one (1) chaperon per camp (**see attached enclosure 2**) who shall be assigned to oversee the participating District SSLG Presidents.
5. For the protection of both parties and the participants, waiver shall be complied with by the latter (**see attached enclosure 3**).





6. The Division Youth Formation Coordinator shall coordinate with the PYDO for the transportation of the participants from their Municipalities to the venue.
7. The fund for this activity shall be charged to the Provincial Youth Development Office, however travel expenses of the identified chaperons shall be charged against the School MOOE/local funds.
8. DepEd personnel who shall render service for this activity shall be entitled for Compensatory Time Off or Service Credit.
9. The issuance of this memorandum shall serve as **Travel Authority** for those concerned.
10. Immediate dissemination of this memorandum is desired for guidance.
