

CREATION OF DISTRICT QUALITY ASSURANCE TEAM (DQAT)

1. With the mandate of curriculum development, enrichment and localization and an objective to develop programs and strategize to localize, indigenize, and contextualize competencies in the curriculum and to encourage learning innovation.
2. To effectively implement the mandate mentioned/stated above a **District Quality Assurance Team (DQAT)** shall be created.
3. Membership should be Master Teachers who has the skill to evaluate the content and language aspect of the developed learning materials (LMs). Lay-out and design evaluators may be selected from the division trained pool of illustrators. They will be called Learning Resource Evaluators (LREs).
4. **Composition:** preferably three (3) for each area – content, language, and layout and design. Elementary, Junior, and Senior level should be well represented. Computer literate is desired.
5. All developed learning resources, in any form, the Learning Resource Coordinator (LRC) of the school will collect and turn-over to the Learning Resource Coordinator of the district and forward it to the DQAT to undergo quality assurance. The PSDSs/PICs will review before submitting it to the Education Program Supervisor of the subject area for final quality assurance. Hard and soft copy should be submitted.
