

1. Pursuant to the Memorandum issued by Malcom S. Garma, Assistant Secretary and Officer-In-Charge, Office of the Undersecretary for Operations, dated July 7, 2025 and the Regional Memorandum No. 998 s. 2025, this Office, through the Schools Governance and Operations Division, particularly the Learner Rights and Protection, instructs all schools to undertake the **Collection, Consolidation, and Validation of Reported Learner Rights and Protection Concerns for S.Y. 2023-2024 on or before September 15, 2025.**
2. Thus, all private and public schools must undertake the collection and consolidation of reported learner rights and protection concerns, in strict compliance and conformity with the provisions of Phase I: Collection and Consolidation Process and set forth therein, to wit:

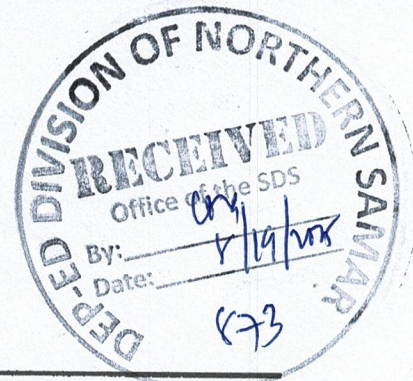
