REGIONAL CELEBRATION OF THE WORLD TEACHERS' DAY



1. 3. There will be a registration fee of **Two Hundred Fifty Pesos (Php 250.00)** for each participant for the **Fund Run**. Payment may be made in cash or check, payable to DepEd Leyte Division, and shall be charged against the respective Division Fund of the participants. On-site registration will be conducted at the Leyte Division Compound beginning at 3:30 A.M on September 19, 2025.

Expenses relative to the conduct of this activity shall be sourced as follows: the lunch provision for all participants shall be charged to the Leyte Division existing fund; the breakfast and morning snacks shall be charged to the Regional Office-ESSD MOOE; while transportation, per diem, accommodation, t-shirts, and other incidental expenses shall be charged against the participants' respective local funds, MOOE, or other available fund sources, all of which are subject to the usual accounting and auditing rules and regulations.
5. This issuance shall serve as a Travel Authority for those concerned.
