**ALLOCATION AND DOWNLOADING OF FUNDS FOR THE GULAYAN SA PAARALAN PROGRAM (GPP) IMPLEMENTATION IN SELECTED SCHOOLS**

1. The **Schools Governance and Operations Division (SGOD) – School Health Section**, in line with the directives of the **Bureau of Learner Support Services – School Health Division (BLSS-SHD)**, is tasked with coordinating, overseeing, and supporting the implementation of the **School-Based Feeding Program (SBFP), Water, Sanitation, and Hygiene (WASH) in Schools (WinS) Program, Gulayan sa Paaralan Program (GPP)**, and the **Integrated School Nutrition Model (ISNM)** at the division and school levels.
2. Furthermore, complementary programs that strengthen and ensure the successful implementation of the SBFP within our schools:
  - a. **WinS Program** – ensures the provision of safe drinking water, adequate sanitation facilities, and the promotion of proper hygiene practices among learners.
  - b. **Gulayan sa Paaralan Program (GPP)** – supports the establishment and maintenance of school vegetable gardens to create a healthy food environment and promote proper nutrition and healthy eating habits among learners.
3. To ensure the effective implementation of the GPP, **ten (10)** selected schools shall be allocated funding amounting to **Ten Thousand Pesos (P10,000.00)** each. The following are the selected schools for Fund Allocation:
