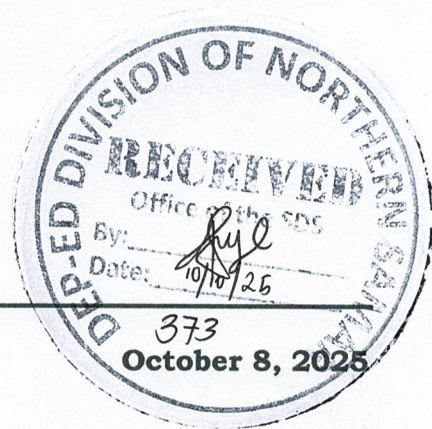

DIVISION MEMORANDUM

**IMPLEMENTATION OF MODULAR INSTRUCTION DURING THE CONDUCT OF
NORTHERN SAMAR PROVINCIAL ATHLETIC ASSOCIATION (NSPAA) MEET
FOR SY 2025-2026**

1. In connection with the conduct of the Northern Samar Provincial Athletic Association (NSPAA) Meet for SY 2025-2026, scheduled on October 15-19, 2025, several schools will be affected from October 13-20, 2025 due to the participation of learner-athletes, coaches, officiating officials, and members of the technical working groups/committees. As the event coincides with regular school days, it is imperative to ensure that learning continuity is not disrupted.

2. To this end, all affected schools are hereby directed to implement modular instruction during the duration of the NSPAA Meet. This alternative delivery mode shall ensure that learners continue their academic engagement while regular classes are temporarily suspended.

3. Specifically, the following guidelines shall be observed:

- **District Supervisors** are encouraged to provide support and guidance to school heads in planning and monitoring the implementation of modular instruction.
- **School Heads** must ensure that appropriate learning modules are prepared, quality-assured, and distributed to all learners prior to the start of the event.
- **Teachers who will serve as coaches, officiating officials and members of the technical working groups/committees** are likewise required to prepare and provide modules for their respective classes before their departure. This ensures that their learners are still able to continue learning even in their absence.
- **Schools designated as billeting quarters** are instructed to make necessary preparations to accommodate delegations, including ensuring the safety, cleanliness, and functionality of facilities. School Heads must also coordinate with the organizing committee and local authorities to minimize disruption to school operations and ensure the security of school property. Additionally, these schools must implement modular instruction for their own learners during the affected period to maintain learning continuity.

- **Monitoring mechanisms** should be in place to track learners' progress and provide feedback once regular classes resume.
 - **Documentation** of the implementation of modular instruction, including distribution logs and learner outputs, must be submitted to the Schools Division Office through the Curriculum Implementation Division (CID) for evaluation and record-keeping.
 - **Parents and guardians** must be informed of the temporary shift in instructional delivery and their role in supporting learners at home. Schools may use advisories, text blasts, or parent group meetings to facilitate this.
4. This directive is issued to uphold the Department's commitment to uninterrupted learning while supporting the holistic development of our learner-athletes and recognizing the professional contributions of our teaching personnel.
5. Immediate dissemination of and compliance with this Memorandum are desired.
