**CONDUCT OF HEALTHY LEARNING INSTITUTIONS FOR LAST MILE  
ELEMENTARY SCHOOLS (HLI-LMES) ADOLESCENT MENTAL HEALTH AND

1. In line with the implementation of the **Healthy Learning Institutions (HLI)** initiative, which includes a total of **one hundred thirty (130) Last Mile Elementary Schools (LMES)** in the Schools Division of Northern Samar, the Department of Health – Eastern Visayas Center for Health Development (DOH-EVCHD), in collaboration with the Provincial Health Office and with the support of this Office, shall conduct a two-day activity titled: **“Healthy Learning Institutions for Last Mile Elementary Schools (HLI-LMES): Adolescent Mental Health and Psychosocial Support (AMHPSS) Training of Trainers.”**
2. The activity will be held at **Dencio’s Venue and Catering Services**, Brgy. Dalakit, Catarman, Northern Samar, on **October 23–24, 2025**. This schedule supersedes the original date indicated in the communication letter from the Provincial Health Office dated October 13, 2025, due to adjustments in venue availability and other logistical considerations.
3. The activity shall be participated in by eight (8) DepEd Nurse Program Coordinators and thirty-six (36) school nurses. (Please see attached list of participants.)
4. Accommodation shall be provided for participants residing outside Catarman, Northern Samar. Kindly coordinate with the Secretariat upon arrival at the venue.
5. All expenses relative to the conduct of this activity—such as meals, venue, and accommodation—shall be charged to the **HLI Fund** managed by the Department of Health – Eastern Visayas Center for Health Development (DOH-EVCHD). Meanwhile, travel and incidental expenses of DepEd participants and facilitators shall be charged to their respective local/school/division
