1. This division announces the conduct of the Live-out **Seminar on Special Patent Application and Title Transfer Procedures for School Sites under the DepEd Sites Titling Program, Batch 3**, to be held on November 25, 2025 to November 26, 2025. **Venue will be announced in a later memorandum.** Conduct of said capacity building will be in compliance with DepEd Memorandum OULLA-2025-203 dated February 5, 2025, issued by the Office of the Undersecretary for Legal and Legislative Affairs and the Sites Titling Office directing Schools Division Offices to secure absolute ownership of public-school sites.
2. Participants to the said activity will be school heads and Administrative Officers of the schools of identified schools with viable applicants for Special Patent and Transfer of Title. *See attached enclosure - List of Participants.*

Participants are expected to gain a deeper understanding of the legal and procedural aspects of school site titling including application for special patents and the transfer of registered titles from national donors to the Department of Education. Their enhanced knowledge will enable them to confidently navigate the requirements and engage with relevant agencies such as DENR, DAR, the Register of Deeds, and the Provincial Assessor's Office.
