**CONDUCT OF DIVISION ROLL OUT TRAINING-WORKSHOP ON THE  
IMPLEMENTATION OF THE CHILDREN AND ADOLESCENTS RISK SCREENER  
(CARS)**


1. In support of Republic Act No. 11036 or the Philippine Mental Health Law, and in recognition of the increasing number of learners experiencing mental health concerns, the Schools Division of Northern Samar shall conduct a two (2)-day **Division Roll-Out Training-Workshop on the Implementation of the Children and Adolescents Risk Screener (CARS)**. This activity aims to capacitate school health personnel and guidance advocates in the early identification and support of learners at risk of mental health problems through the use of validated screening tools.
2. Specifically, the training-workshop aims to:
  - a. train participants in the use of the Children and Adolescents Risk Screener (CARS) as a universal mental health screening tool;
  - b. equip them with the knowledge and skills to administer, interpret, and utilize screening results for early intervention;
  - c. strengthen school-based referral and intervention systems; and
  - d. promote the integration of evidence-based screening and early intervention in school mental health programs.
3. Expected participants include **ALL School Nurses/DepEd Nurses** — both Division-based and school-based (autonomous and plantilla) — as well as **twenty-eight (28) selected Guidance Counselor Designates** from elementary and secondary schools.
4. The final venue and date of the activity shall be announced in a separate issuance.
5. All expenses relative to the conduct of this activity, including meals, accommodation, venue, and materials, shall be charged to the **School Mental**

**Health Program (SMHP) – Program Support Fund (PSF)**, subject to the usual accounting and auditing rules and regulations.
