COLLECTION, CONSOLIDATION, AND VALIDATION OF REPORTED LEARNER RIGHTS AND PROTECTION CONCERNS FOR S.Y. 2024-2025

All others concerned

1. Pursuant to the Memorandum issued by Malcom S. Garma, Assistant Secretary and Officer-In-Charge, Office of the Undersecretary for Operations, dated September 17, 2025, and the Regional Memorandum No. 1479 s. 2025, this Office, through the Schools Governance and Operations Division, particularly the Learner Rights and Protection, instructs all schools to undertake the **Collection, Consolidation, and Validation of Reported Learner Rights and Protection Concerns for S.Y. 2024-2025 on or before December 15, 2025.**
2. Thus, all private and public schools must undertake the collection and consolidation of reported learner rights and protection concerns, in strict compliance and conformity with the provisions of Phase I: Collection and Consolidation Process, as set forth therein, to wit:

a. **STEP 1:**

- b. **Step 2:** Transcribe the accomplished data into the prescribed Google Form corresponding to the grade level, through the following links:

The disaggregated data shall thereafter be transmitted to the concerned field for validation by the duly designated focal persons of the Regional Offices (ROs) and the Schools Division Offices (SDOs).
3. The Public School District Supervisors/Districts In-Charge shall monitor and ensure that all schools within their jurisdiction comply with this collection, consolidation, and validation of reported learner rights and protection (LRP) concerns for school year 2024-2025.
