ESTABLISHMENT AND COMPOSITION OF THE DIVISION WATER, SANITATION, AND HYGIENE (WASH) IN SCHOOLS (WinS) TECHNICAL WORKING GROUP (TWG)

1. This Memorandum is issued pursuant to **DepEd Order No. 10, s. 2016**, the *Policy and Guidelines for the Comprehensive Water, Sanitation, and Hygiene in Schools Program*, and **DepEd Memo No. 194, s. 2018**, which provides the implementing guidelines. These issuances authorize the creation and operation of the **Division Water, Sanitation, and Hygiene (WASH) in Schools (WinS) Technical Working Group (TWG)**, to which this Office hereby establishes to ensure proper oversight, technical support, advocacy, and monitoring of WASH initiatives in schools.
2. The group shall comprise representatives from the **Schools Governance and Operations Division (SGOD)**, the **Curriculum Implementation Division (CID)**, and other relevant offices within the Schools Division Office, as well as from **Non-Government Organizations, partner agencies, and other stakeholders**, thereby forging coordination and partnership to ensure a multi-sectoral approach and strengthen the implementation of the WinS Program.
3. In line with the foregoing, this Office hereby adopts the composition of the **WinS Technical Working Group (TWG)**. The TWG is tasked to:
 - a. Oversee the work of the school technical working groups, approve outputs, and provide technical assistance as needed.
 - b. Support advocacy of the WinS Policy to other sectors.
 - c. Monitor school implementation, including the integration of water, sanitation, and hygiene in the curriculum.
