**ORIENTATION ON THE ADMINISTRATION OF THE COMPUTER-BASED  
NATIONAL CAREER ASSESSMENT EXAMINATION  
FOR SCHOOL YEAR 2025-2026**

1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), with the assistance of the Regional Offices (Ros), Schools Division Offices (SDOs), and secondary school personnel, will administer the Computer-Based National Career Assessment Examination (CB-NCAE) to all Grade 10 learners currently enrolled in public and private schools with government permit and recognition. The examination will be conducted during the regular classes from December 2025 to January 2026, which will serve as the testing window.
2. Relative to this, the Schools Governance and Operations Division (SGOD) and Schools Management Monitoring and Evaluation (SMME) section, will conduct a division orientation on the Administration of the Computer-Based National Career Assessment Examination (CB-NCAE) on the following schedules:


