**CONDUCT OF HEALTHY LEARNING INSTITUTIONS FOR LAST MILE ELEMENTARY SCHOOLS (HLI-LMES) KAMUSTAHAN SESSION**

1. In line with the implementation of the **Healthy Learning Institutions (HLI)** initiative, which includes a total of **one hundred thirty (130)** **Last Mile Elementary Schools (LMES)** in the Schools Division of Northern Samar, the **Department of Health - Eastern Visayas Center for Health Development (DOH-EVCHD)** through the **Northern Samar Provincial Department of Health Office (PDOHO)**, in collaboration with the **Provincial Health Office (PHO)** and with the support of this Office, an activity titled: "**Healthy Learning Institutions for Last Mile Elementary Schools (HLI-LMES): Kamustahan Session.**"

All expenses relative to the conduct of this activity—such as meals and venue—shall be charged to the **HLI Fund** managed by the **Department of Health - Eastern Visayas Center for Health Development (DOH-EVCHD)** through the **Northern Samar Provincial Department of Health Office (PDOHO)**. Meanwhile, travel and incidental expenses of DepEd participants and facilitators shall be charged to their respective local/school/division funds or MOOE, subject to the usual accounting and auditing rules and regulations.
6. This Memorandum shall serve as the **Official Travel Authority** for all concerned participants and facilitators.


