SUBJECT: **DIVISION-WIDE RE-ORIENTATION ON THE LIQUIDATION OF MOOE AND OTHER FUNDS AND THE NEW GOVERNMENT PROCUREMENT REFORM ACT (RA 12009)**

DATE: **February 6, 2026**

1. To ensure the efficient, transparent, and compliant utilization of school funds, this Office shall conduct a one-day **District Orientation on MOOE and Other Funds Liquidation and The New Government Procurement Reform Act (RA 12009)** for all School Heads and Administrative Assistants (II and III).

This activity aims to align school-level financial operations with the newly enacted **Republic Act No. 12009 (New Government Procurement Reform Act)**, which streamlines procurement processes while maintaining strict accountability.

2. This orientation aims to:
 - Re-orient participants on MOOE and Other Funds Liquidation Report Documentation
 - Provide a comprehensive overview of **RA 12009** and its impact on school-based procurement.
 - Re-Orient participants on **D.O 08 s. 2019, D.O. 36 s. 2025, D.O. 46 s. 2022** and **P.D. 1445**
 - Enhance the technical capacity of ADAS II and III in preparing liquidation report documentation.
