
**PLANNING AND COORDINATION CONFERENCE ON THE DEVELOPMENT OF

 - c. discuss and strengthen mechanisms to enhance the implementation of LAC as a school-based professional learning platform; and
 - d. craft next-step commitments, including the development of a consolidated, time-bound implementation plan and monitoring framework for the resource package development and quality assurance phase.

5. Expenses incurred in the conduct of this activity such as meals and honorarium of invited Content Experts from the University of Eastern Philippines
