DIVISION-BASED TRAINING OF DIVISION SUPERVISORS AND DISTRICT HEADS ON MULTIGRADE INSTRUCTIONS AND INSTRUCTIONAL LEADERSHIP INTEGRATING SOCIAL & EMOTIONAL LEARNING IN MULTI-GRADE SCHOOLS

1. In support of the Department of Education's commitment to providing high-quality education, this Schools Division Office, through the Curriculum Implementation Division, will conduct a 3-day live-in training titled Division-Based Training of Division Supervisors and Untrained District Heads on Multigrade Instructions and Instructional Leadership Integrating Social Emotional Learning (SEL) on **March 17-19, 2026 at Yankie Farm and Resort, Bobon, Northern Samar.**
2. The training aims to:
 - a. provide clear instructions and guidance on effective instructional leadership strategies for managing multigrade classrooms;
 - b. enhance participants' skills in using differentiated instruction to cater to diverse learning styles, abilities, and learning pace;
 - c. foster supportive and equitable learning opportunities integrating SEL in multigrade schools.
3. The participants in this activity include Education Program Supervisors, untrained District Heads, Learning Facilitators, TWG, and Program Management Team of this Schools Division (see attached enclosure).
4. Expenses incurred in the conduct of this three-day activity—such as meals, snacks, and accommodation of the participants—shall be charged against the **Program Support Funds for Multigrade Schools for Calendar Year 2025**, while travel expenses shall be charged against Local Funds or School MOOE, subject to the usual accounting and auditing rules and regulations.
