Manage the distribution and retrieval of test materials to the examiners and ensure adherence to test security and protocols. Complete report forms and/or prepare reports on the overall conduct of the test (logistical issues, test irregularities, and breaches of security).
ROVING PROCTOR (RP)	<ul style="list-style-type: none"> Monitor 5 to 10 testing rooms and provide necessary assistance to the room examiners (e.g., insufficient test booklets and/or answer sheets). Document logistical issues, test irregularities, and breaches of security and report in detail to the chief examiner.
ROOM EXAMINER (RE)	<ul style="list-style-type: none"> Lead the administration of the A&E Test within the assigned testing room. 


