1. This Schools Division, through the Curriculum Implementation Division, in partnership with the NORFIL Foundation, Inc. and the Provincial Government of Northern Samar through the Provincial Disability Affairs Office, will conduct the **4th SIGLAKAS (Sigla at Lakas Sports and Games) Festival**, a province-wide, one-day event for **300 children and youth with disabilities** from the **24 Local Government Units (LGUs) of Northern Samar**, on **September 7, 2026**, at **Catarman National High School, Catarman, Northern Samar**.
