1. This Office, through the Curriculum Implementation Division (CID) will conduct the **Division 2026 Technovators** on September 5-7, 2026, with the theme; "Youthful Creativity, Cultural Brilliance: Crafting a Bright Future in the Creative Industries." The activity will be held at Bobon School for Philippine Craftsmen, Bobon District.
2. This activity aims to:
 - a. Provide learners with a platform to develop and showcase their skills, talents, and competencies aligned with the creative industries, fostering innovation, entrepreneurship and appreciation for local arts and culture;
 - b. Ensure inclusive and equitable participation of learners for Special Needs education (SNEd), Alternative Learning System (ALS), Indigenous People Education (IPed), and Madrasah Education Program (MEP) and Special Curricular Programs, enrolled in both public and private schools from Key Stage 2-4, providing them equal opportunity to exhibit their talents in creative arts; and
 - c. Strengthen partnerships among schools and local government units to support talent development and community enrichment.
3. The expected participants to this activity are the champion contestants and coaches during the district Technovators contest. Every contestant and coach shall register an amount of One hundred pesos (P100.00) per participant to the Division Cashier's office to defray the expenses during the Division Technovators.
4. Participants who travel or render services on weekends and holidays may avail Service Credits/Compensatory Overtime Credit (COC) equivalent to eight (8) hours of service per day whichever is applicable in accordance with DepEd Order No. 67, s. 1998 and CSC Memorandum Circular No. 09, s. 1998.

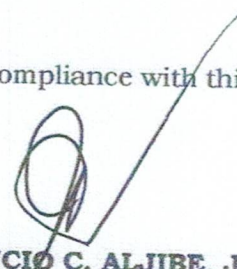

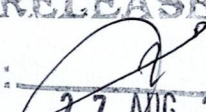
