PROJECT LEARNER CARE: Protecting Learners. Empowering Futures

1. In line with the commitment of the Department of Education to uphold learner rights, child protection, and the promotion of youth empowerment, this Office announces the conduct of **Project Learner CARE: Protecting Learners. Empowering Futures**, on September 7, 8, and 9, 2026, at 10:00 AM, at Bobon Central Elementary School, Bobon, Northern Samar.
2. Project Learner-CARE is a division-based project designed to promote learner rights and protection while strengthening youth development through education, empowerment, and active participation. The project aims to create a safe, inclusive, and supportive school environment where learners are aware of their rights, protected from abuse and discrimination, and equipped with skills for leadership, responsibility, and personal growth.
3. The participants for this activity shall be the SSLG Advisers, the SSLG Presidents of the current year, and YES-O Presidents. In cases where the SSLG President or the YES-O President is unavailable, the preceding position may take responsibility for attending the event. There will be five (5) teams for this event. **Refer to the attachment for reference and guidance.**
4. The SSLG Adviser shall serve as the chaperone for the SSLG President and the YES-O President. The SSLG Adviser shall ensure that the learners duly accomplish the consent form and present it to the secretariat during participant registration. **The consent form is attached herewith.**

5. Participants shall provide their own bedding and personal necessities (such as personal hygiene products).
6. The participants, if possible, are encouraged to bring painting materials for the Banner Making Activity.
7. SSLG Advisers are required to prepare a 3-minute video presentation for their conducted or accomplished SSLG activities for this School Year (starting from January). This will be presented during the KUMUSTAHAN WITH THE SSLG ADVISERS.
8. Teaching personnel and non-teaching personnel who participated in this activity shall be entitled to claim Service Credits or Compensatory Time-Off, whichever is applicable, if the activity falls during a holiday or weekend, as such are subject to the existing DepEd policy or the Civil Service Rules.
9. The participants in this event shall be provided with meals and snacks during the course of the event. However, transportation costs, including incidental expenses, including per diem, shall be charged against the Division/School MOOE/Local funds, subject to the government rules on accounting and auditing procedures. **The first meal on the first day is lunch.**
10. This issuance shall serve as **Travel Authority** for those concerned.
